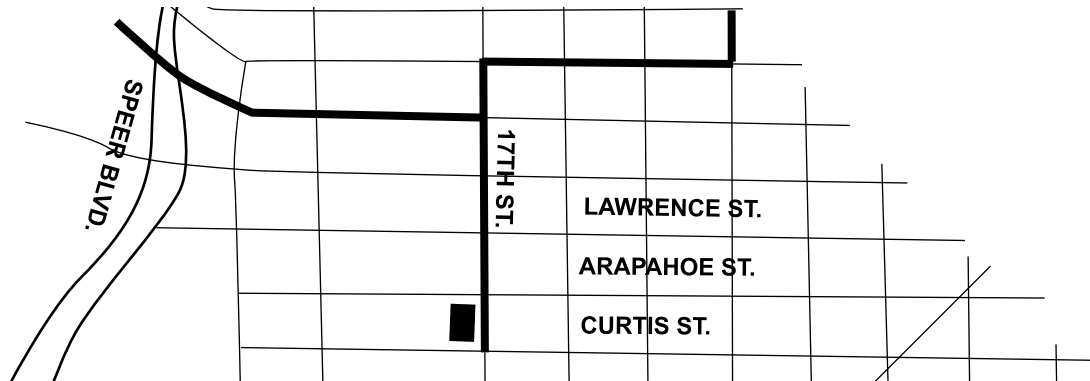
DIRECTIONS
